Every retiree should have received a packet in the mail outlining the 5 choices: Blue Cross Blue Shield PPO; Blue Cross Blue Shield HMO; Kaiser Permanente Signature HMO; CIGNA Medicare Surround and Health Reimbursement Account. A handout of the 2011 Retiree Medical Plan Side-by-side comparison was reviewed and each plan's differences discussed. Questions were answered. Prescription drug plans were also discussed and questions answered. Representatives from Blue Cross Blue Shield and Kaiser Permanente discussed their plans. The new HRA (Health Reimbursement Account) was explained and discussed. Questions were answered. If anyone has not received a packet from Cobb County, they should contact them. Dental and Vision plans options are included in the packet.
