#### **PROGRAM:**

**CIGNA** Representative Marybeth Luptowski was here to answer questions and discuss any concerns the members have. This is for the members 64 and under that has Cigna coverage.

Marybeth said the transition plan in the beginning did not work. Cigna had a volume issue with the plan the volume was much higher and had to hire more people to help with the calls. She apolized on behalf of herself and Cigna for any inconvenient we may have encountered.

She discussed home delivery why it takes longer; express script has to transfer to Cigna. First prescription takes a lot of double checks to make sure the prescription are issued by a physician, you can have your physician electronically email them or you can go on mycigna.com (accept all major credit cards) to order, best to call Cigna first to let them know you are ready to place an order. Contact Cigna if you have further questions or concerns.

Tony Hagler Human Resources Director was in attendant and was asked, was there an approved Ambulance Service? The answer was no.

President Stone discussed the reason former Public Safety Director Jack Forsythe was not on the program. He said there were some concerns about him speaking.
